In accordance with the City of Apache Junction, AZ Ordinance # 1434, if you have an active police alarm system in the City of Apache Junction, Arizona, it must be registered with the City separately. The fee for an alarm registration/renewal is set forth below and shall be paid by the alarm user. For registered residential location for 1st to 2nd burglary/robbery panic false alarm there is no assessment but warning letter will be issued, for 3rd burglary/robbery panic false alarm assessment is \$50.00, for 4th burglary/robbery panic false alarm will be charged in increments of \$50.00 for each false alarm. For registered commercial location for 1st burglary false alarm there is no assessment but warning letter will be issued, for 2nd burglary false alarm assessment is \$50.00, for 3rd burglary false alarm will be charged in increments of \$50.00 for each false alarm. For registered commercial location for 1st robbery panic false alarm there is no assessment but warning letter will be issued, for 2nd robbery panic false alarm assessment is \$100.00, for 3rd robbery panic false alarm will be charged in increments of \$100.00 for each false alarm. For all unregistered location 1st false alarm administrative penalty is \$100.00, for 2nd false alarm administrative penalty is \$200.00, for 3rd and above false alarm the alarm user may be subject to criminal and/or civil charges penalties and fees. PM AM will not charge for 3rd and above false alarm
